

2016 & Recap of The Food Drive Sponsored by California State Employees In partnership with California Emergency Foodlink

Thank you to all you participated in the 2016 Food Drive!! Through your time, efforts and donations, Foodlink is able to feed over 102,000 people in the Sacramento area every month. We would not be able to help the hungry in our community without support from California State Employees. **Thank you for helping in the fight against hunger!**

A total of 81 State agencies, departments and offices participated from throughout the greater Sacramento metropolitan area. Through California State Employees' efforts, 1,171,711 pounds of food and \$1,114,141 were donated. This is equivalent to a combined total of **617,776 pounds of food.**

In 2016 a new Turkey Drop was also implemented as part of the Food Drive! Over 6,000 turkeys were donated giving over 6,000 families in the Sacramento area a special holiday meal.

The food collected during the 2016 State Employees' Food Drive is distributed by California Emergency Foodlink in small amounts as needed to over 140 of Foodlink's partner agencies over a period of several months. The money that was donated will be used to buy bulk items, such as rice, peanut butter, dry beans, and fresh produce which is costly for Foodlink's partner agencies to purchase on their own.
